- G. We shall create website and upload the requisite statutory compliance documents on our website every month.
- H. We will keep the register/records updated of all related statutory provisions for inspection of Government Officer/Inspectors any time.
- I. We also Undertake that we will maintain all documents, Return, Forms as per above Act & Rules.
